2. BOARD AND EXECUTIVE REPORT

2.1 Board Chair's Report

The board chair reported on her past and upcoming meetings:

- Skills for Jobs Task Force the task force's final meeting occurred on September 17th with the final report now being finalized before going to the Minister.
- CCDA National Stakeholders Meeting.
- Canadian Apprenticeship Forum (CAF) Executive meetings. The CAF board elections are coming up and j'Amey will remain on the board by acclamation.
- CAF webinar on supporting women in trades strategy.
- CAF virtual symposium.
- Trades Women Build Nations there will be an on-line conference on Oct. 16 and 17, 2020. There will be no charge for attending this virtual conference and everyone is welcome.
- Board standing committee meetings.
- The chair met with the Minister of Advanced Education to discuss several issues such as board appointments, apprenticeship program challenges, the Skills for Jobs Task Force, and apprentice employment.

In addition, the board chair advised that Craig Mathes has finished his final term as board member and vice chair. The board chair acknowledged his many contributions to the board and to the apprenticeship system. He will be missed by all.

2.2 Board Members' Reports

Board members reported that they participated in industry events and meetings since the last board meeting including board standing committee meetings and PAC/OC meetings as Board Liaisons. In addition, some board members provided comments on the current state of their industry.

2.3 Executive Director's Report

Policy and Standards

- The department continues to work on sustaining apprenticeship programs affected by the COVID-19 pandemic.
- Technical training and class registrations:
 - Apprenticeship and Industry Training continues to work with post-secondary institutions on class registrations. This time last year, approximately 11,600 apprentices registered for classes, this year's enrollments are around 10,500, which is a slight decrease. Many institutions are offering classes via virtual learning, while some still offer some in-person instruction.
 - Registrations for upcoming intakes after Christmas are lower, but consistent with the numbers from the same time period last year. Communications will go out shortly to apprentices to encourage them to register for their classroom learning.
- The Alberta government is highly focused on facilitating the creation of jobs and economic recovery. Since the pandemic began, more than 300,000 Albertans have become unemployed. Women and youth were especially affected by the economic downturn, mostly due to their industry (i.e. service sector). The government wants to ensure that people are getting back to work and is focused on the attraction and development of new businesses in Alberta. Advanced Education has a lead role in ensuring that Albertans are educated to fill these new opportunities. One of the strategies the government is exploring is supporting Women Building Futures and CAREERS: the Next Generation organizations to develop programs that will get more women and youth into the workforce.
- Andy Weiler, our previous Assistant Deputy Minister, has moved on to NAIT to work on developing the NAIT Collegiate, and is a high priority for government. The Collegiate will be a high school that bridges to post-secondary education with a focus on science, technology, engineering and mathematics (STEM) and apprenticeship. Mike Fernandez is the new Assistant Deputy Minister for Apprenticeship and Student Aid. Mike has extensive experience within the Government of Alberta and was previously the ADM of the Parks Division in Alberta Environment and Parks.
- The Canadian Council of Directors of Apprenticeship (CCDA) National Stakeholders Meeting was held on October 7, 2020 and identified core stakeholder's challenges with apprenticeship education during the COVID pandemic. The stakeholders were also given an opportunity to comment on current CCDA strategic priorities.

Operations and Client Connections

• Approximately 6,000 apprentices signed up for classroom instruction on the first day of registration.

- Statistical highlights as of September 30, 2020:
 - o 44,938 registered apprentices in the system, down 3% from same time last year
 - o 16,909 new apprentices in first period, up 1% from same time last year
 - 4,723 women apprentices, down 1% from same time last year
 - o 2,685 indigenous apprentices, up 3% from same time last year.
- Other statistics since June:
 - 306,000 logins into MyTradesecrets (including 4,191 employers to validate apprentice applications)
 - o 4,664 applications of all types were submitted, including 155 RAP
 - 10,196 apprentices registered for classroom instruction through MyTradesecrets
 - o 6,306 apprenticeship ID cards generated by apprentices through their MTS account
 - 8,734 documents uploaded by apprentices via their MTS account which could be anything from scans/pictures of record book entries, transfer cards, etc.
 - Over 1,500 exams have been delivered at AIT offices (with limited capacity due to COVID health orders).
- All AIT Offices are now open and adapting to the COVID-19 health guidelines.
- Apprenticeship and Industry Training is working with the post-secondary institutes on options for delivering the red seal exams for final period apprentices.
 - 1,837 potential red seal exams to be delivered between now and the end of this calendar year with over 900 required around Dec 18th.

The following discussion occurred from the institutional reports:

- The board asked if instruction has become more expensive during COVID. The institutions reported that they have been able to fund additional costs for virtual delivery, increased personal protection equipment, sanitization, and technology licenses within their current budgets.
- Further in the meeting, there was discussion on whether there were affordable technology supports (ie. loanable computer equipment and/or free Wi-Fi access) available for apprentices while they were attending classroom instruction.
