Interpretation

- 1 (1)** In this Order,
- (a) “apprentice” means a person who is an apprentice in a branch of the trade;
 - (b) “certified journeyman” means a certified journeyman as defined in the *Apprenticeship Program Regulation*;
 - (c) “new apprenticeship program” means an apprenticeship program under the trade Regulation;
 - (d) “previous Regulation” means the *Ironworker Trade Regulation* (AR 285/2000);

(e) “technical training” means technical training as defined in the *Apprenticeship Program Regulation*;

(f) “trade” means the occupation of ironworker that is designated as a compulsory certification trade pursuant to the *Apprenticeship and Industry Training Act*;

(g) “trade Regulation” means the *Ironworker Trade Regulation*.

- 2** Where a person is an apprentice in a previous apprenticeship program immediately before July 4, 2006 that apprentice must, subject to this Order, enter into one of the new apprenticeship programs.

PART 1

APPRENTICES IN THE PREVIOUS IRONWORKER APPRENTICESHIP PROGRAM

Interpretation

- 3** In Part 1 of this Order

(a) “existing apprentice” means a person who immediately before July 4, 2006 was an apprentice in the previous apprenticeship program;

(b) “previous apprenticeship program” means an apprenticeship program in the ironworker branch of the trade under the previous Regulation.

- 4** An existing apprentice who had not successfully completed the technical training that was required in respect of the first period of that apprentice’s previous apprenticeship program immediately before July 4, 2006

[Board Order 5/2006]

(a) enter the first period of a new apprenticeship program,

(b) is to be given credit for the hours of on the job training the apprentice had acquired in the apprentice’s previous apprenticeship program, and

(c) must successfully complete the remaining requirements of the new apprenticeship program in order to be granted a trade certificate in the trade.

- 5** **(1)** This section applies to existing apprentices who enter into a new apprenticeship program in the ironworker branch of the trade.
- (2)** An existing apprentice who had successfully completed the first, 2nd or 3rd periods of apprenticeship in the previous apprenticeship program immediately before July 4, 2006 is to be given credit for having successfully completed the first, 2nd or 3rd periods, as applicable, of the new apprenticeship program in the ironworker branch of the trade.

- (3) An existing apprentice who had not completed the 2nd or 3rd periods of apprenticeship immediately before July 4, 2006 is to be given credit for the technical training the apprentice had successfully completed and the hours of on the job training the apprentice had acquired in the apprentice's previous apprenticeship program.

- (4) Subject to credit being granted under subsections (2) and (3), an existing apprentice must successfully complete the requirements of the new apprenticeship program in the ironworker branch of the trade in order to be granted a trade certificate in that branch.

- (5) Notwithstanding section 2 and subsection (4), an existing apprentice who had successfully completed all the technical training requirements in the apprentice's previous apprenticeship program immediately before July 4, 2006, may, on successful completion of the remaining requirements of the previous apprenticeship program, be granted a trade certificate in the ironworker branch of the trade.

- 6 (1) This section applies to existing apprentices who enter into a new apprenticeship program in the structural/ornamental branch of the trade.

- (2) An existing apprentice who had successfully completed the first or 2nd periods of apprenticeship in the previous apprenticeship program immediately before July 4, 2006 is to be given credit for having successfully completed the first period of the new apprenticeship program in the structural/ornamental branch of the trade.

- (3) An existing apprentice
- (a) must enter the 2nd period of the new apprenticeship program in the structural/ornamental branch of the trade,
 - (b) is to be given credit for the hours of on the job training the apprentice had acquired in the apprentice's previous apprenticeship program, and
 - (c) must successfully complete the remaining requirements of the new apprenticeship program in the structural/ornamental branch of the trade in order to be granted a trade certificate in that branch.

- 7 (1) This section applies to existing apprentices who enter into a new apprenticeship program in the reinforcing branch of the trade.

- (2) An existing apprentice who had successfully completed the first or 2nd periods of apprenticeship in the previous apprenticeship program immediately before July 4, 2006 is to be given credit for having successfully completed the first period of the new apprenticeship program in the reinforcing branch of the trade.

- (3) An existing apprentice
- (a) must enter the 2nd period of the new apprenticeship program in the reinforcing branch of the trade,
 - (b) is to be given credit for the job training that the apprentice had acquired in that apprentice's previous apprenticeship program, and
 - (c) must successfully complete the remaining requirements of the new apprenticeship program in the reinforcing branch of the trade in order to be granted a trade certificate in that branch.

PART 2

APPRENTICES IN THE PREVIOUS METAL BUILDING SYSTEMS ERECTOR APPRENTICESHIP PROGRAM

Interpretation

8 In Part 2 of this Order

- (a) "existing apprentice" means a person who immediately before July 4, 2006 was an apprentice in the previous apprenticeship program;

- (b) "previous apprenticeship program" means an apprenticeship program in the metal building systems erector branch of the trade under the previous Regulation.

9 (1) This section applies to existing apprentices who enter into a new apprenticeship program in the metal building systems erector branch of the trade.

- (2) An existing apprentice who had not successfully completed any of the technical training that was required in respect of the apprentice's previous apprenticeship program immediately before July 4, 2006

[Board Order 5/2006]

- (a) must enter the first period of a new apprenticeship program,
- (b) is to be given credit for the hours of on the job training the apprentice had acquired in the apprentice's previous apprenticeship program, and
- (c) must successfully complete the remaining requirements of the new apprenticeship program in the metal building systems erector branch of the trade in order to be granted a trade certificate in that branch.

- (3) An existing apprentice who had successfully completed the first 4 weeks of technical training in the metal building systems erector branch of the trade and acquired less than 1500 hours of on the job training immediately before July 4, 2006

[Board Order 5/2006]

- (a) must enter the first period of the new apprenticeship program in the metal building systems erector branch of the trade,
 - (b) is to be given credit for the hours of on the job training the apprentice had acquired in the apprentice's previous apprenticeship program, and
 - (c) must successfully complete the remaining requirements of the new apprenticeship program in the metal building systems erector branch of the trade in order to be granted a trade certificate in that branch.
- (4)** An existing apprentice who had successfully completed the first 4 weeks of technical training in the metal building systems erector branch of the trade and acquired more than 1500 hours of on the job training immediately before July 4, 2006

[Board Order 5/2006]

- (a) must enter the 2nd period of the new apprenticeship program in the metal building systems erector branch of the trade,
 - (b) is to be given credit for the hours of on the job training the apprentice had acquired in the apprentice's previous apprenticeship program, and
 - (c) must successfully complete the remaining requirements of the new apprenticeship program in the metal building systems erector branch of the trade in order to be granted a trade certificate in that branch.
- (5)** Notwithstanding section 2 and subsections (3) and (4), an existing apprentice who had successfully completed all the technical training requirements in the apprentice's previous apprenticeship program immediately before July 4, 2006, may, on successful completion of the remaining requirements of the previous apprenticeship program, be granted a trade certificate in the metal building systems erector branch of the trade.

| Credit for on the job training | 10 | In granting credit for on the job training for the purposes of this Order, the credit granted may be a lesser amount if the Executive Director is of the opinion that the lesser amount properly reflects the actual amount of on the job training that the existing apprentice had acquired in the branch of the trade in which the existing apprentice is continuing as an apprentice. |
| Existing trade certificates | 11 | (1) A trade certificate granted to a person in the ironworker branch of the trade referred to in the <i>Ironworker Trade Regulation</i> (AR 285/2000) is the equivalent of a trade certificate granted to a person in the ironworker branch of the trade in the trade Regulation. |

- (2) A trade certificate granted to a person in the metal building systems erector branch of the trade referred to in the *Ironworker Trade Regulation* (AR 285/2000) is the equivalent of a trade certificate granted to a person in the metal building systems erector branch of the trade in the trade Regulation.
