Apprenticeship and Industry Training Act

BOILERMAKER TRADE CERTIFICATE AND CREDITS ORDER

Interpretation

1 In this Order,

- (a) “apprentice” means a person who is an apprentice in the trade;
- (b) “existing apprentice” means a person who immediately before June 1, 2009 was an apprentice in the previous apprenticeship program;
- (c) “new apprenticeship program” means an apprenticeship program under the trade Regulation as it exists after June 1, 2009;
- (d) “new first period examination” means the examination based on the revised course outline for the first period of technical training in the new apprenticeship program;
- (e) “new second period examination” means the examination based on the revised course outline for the second period of technical training in the new apprenticeship program;
- (f) “previous apprenticeship program” means an apprenticeship program under the trade Regulation as it existed before June 1, 2009;
- (g) “technical training” means technical training as defined in the *Apprenticeship Program Regulation*;
- (h) “trade” means the occupation of boilermaker that is designated as a compulsory certification trade pursuant to the *Apprenticeship and Industry Training Act*;
- (i) “trade Regulation” means the *Boilermaker Trade Regulation* (AR 264/2000).

Existing apprentices - completion of previous apprenticeship program

2 An existing apprentice who, before June 1, 2009, has successfully completed the technical training in the first and 2nd periods of apprenticeship in the previous apprenticeship program may, in the 2009-2010 school year only, attend the 3rd period of technical training in the previous apprenticeship program, and complete the requirements of the

previous apprenticeship program.

Existing apprentices - requirement to complete the new apprenticeship program

3 An existing apprentice who does not complete the previous apprenticeship program under section 2 must enter into and successfully complete the requirements of the new apprenticeship program.

Existing apprentices - technical training requirements

4(1) An existing apprentice who, before June 1, 2009, has successfully completed the twelve weeks of technical training in the first period of apprenticeship in the previous apprenticeship program is to be given credit for completing the first period of technical training in the new apprenticeship program and is eligible to attend the 2nd period of technical training in the new apprenticeship program.

(2) An existing apprentice who, before June 1, 2009, has successfully completed the technical training in the first and 2nd periods of apprenticeship in the previous weeks in the previous apprenticeship is to be given credit for completing the first and 2nd periods of technical training in the new apprenticeship program and is eligible to attend the 3rd period of technical training in the new apprenticeship program.

(3) An existing apprentice who, before June 1, 2009, has not successfully completed the twelve weeks of technical training in the first period of apprenticeship in the previous apprenticeship must, subject to this Order, complete the first period of technical training in the new apprenticeship program.

(4) An existing apprentice who, before June 1, 2009, has not successfully completed the technical training in the 2nd period of apprenticeship in the previous apprenticeship must, subject to this Order, complete the 2nd period of technical training in the new apprenticeship program.

Credit for existing apprentices

5 Notwithstanding section 4, an existing apprentice who, before June 1, 2009,

(a) has successfully completed

(i) the first six weeks of technical training in the previous of apprenticeship program, and

(ii) the new first period examination

is to be given credit for completing the first period of technical training in the new apprenticeship program and is eligible to attend the 2nd period of technical training in the new

apprenticeship program.

(b) has successfully completed

(i) the twelve weeks of technical training in the first period of apprenticeship in the previous apprenticeship program, and

(ii) the new 2nd period examination

is to be given credit for completing the first and 2nd periods of technical training in the new apprenticeship program and is eligible to attend the 3rd period of technical training in the new apprenticeship program.

Credit for on the job training

6(1) Existing apprentices are to be granted credit for the on the job training they had acquired before June 1, 2009.

(2) In granting credit for on the job training, the credit granted may be a lesser amount if the Executive Director is of the opinion that the lesser amount properly reflects the actual amount of on the job training that the existing apprentice had acquired in the trade.

Requirements to be granted a trade certificate

7 Subject to credit being granted under this Order, an existing apprentice, except one who does not complete the previous apprenticeship program under section 2, must successfully complete the requirements of the new apprenticeship program in the trade in order to be granted a trade certificate in the trade.

Existing trade certificates

8 A trade certificate granted in the trade before June 1, 2009 is equivalent to a trade certificate granted in the trade on or after June 1, 2009.

Coming into force

9 This Order comes into force on June 1, 2009.
