## Apprenticeship ROI Background

- In June 2023, Canadian Apprenticeship Forum (CAF) published findings from their 2022 research study "The Business Case for Apprenticeship in Alberta"
- Goals:
  - 1. Assess costs and benefits of training apprentices
  - 2. Assess why qualified/able employers do not hire apprentices
- Scope:
  - Automotive Service Technician (AST)
  - Electrician
  - Carpenter



## Findings – Return on Investment

Cost-benefit analysis of return on training investment:

Trade	Total Cost	<b>Total Benefits</b>	Net Benefits	ROI
AST	\$435,291	\$703,579	\$268,288	\$1.62
Electrician	\$267,686	\$378,652	\$111,293	\$1.43
Carpenter	\$309,730	\$372,919	\$63,189	\$1.20



## Findings – Net Benefits to Employer

Net benefits to employer per year of apprenticeship

Trade	Year 1	Year 2	Year 3	Year 4
Net Benefits for AST	\$26,780	\$60,888	\$85,706	\$94,913
Net Benefits for Electrician	\$14,557	\$25,924	\$29,221	\$41,265
Net Benefits for Carpenter	\$11,785	\$15,221	\$13,315	\$22,868



Employer Reported Benefits of Hiring Apprentices	% of Employers
Better fit with the organization	91%
Better retention of employees	81%
In-house mentors	79%
Potential for career advancement in the company	76%
Avoids risks of skills shortages	73%
Greater overall productivity	72%
Better relationships with customers	71%
Fewer mistakes	68%
Better health and safety performance	66%

Reasons for not Hiring Apprentices	% of Employers
Not enough continuous contracts to sustain apprenticeships	57%
Not enough apprentices / no-one applies to job postings	23%
Insufficient journeypersons to supervise apprentices	19%
Not a compulsory trade	14%
Potential for apprentice to be recruited by another company	13%
Apprentices require too much of the journeyperson's time	10%
In the past, my apprentices had too many essential skills issues	8%
In the past, my apprentices had too many life management issues	6%
Interruption in apprentice availability due to technical training	5%
Insurance costs	4%
Health and safety concerns related to apprentice training	3%
Worker's compensation costs for apprentices	3%
Other	18%

## **AIT Statistical Profiles**

- Information includes numbers of registered apprentices in each program, classroom instruction attendance and credentials issued.
- Government staff, post-secondary institutions, the Alberta Board of Skilled Trades, and skilled trades stakeholders and external researchers access and use this information for planning and reference.
- Data is almost entirely from ATOMS (Apprenticeship, Trades and Occupation Management System)



#### 2022 AIT Statistical Profile

- As of December 31, 2022, there were approximately 45,200 registered apprentices
  - Up from 39,000 in 2021 & 44,900 in 2020.
- Of those:
  - 5,700 were women;
  - 3,000 self-identified as Indigenous;
  - 2,300 began in RAP;
  - 181 began in a CTS Apprenticeship Pathway; and
  - 80 per cent were registered in 12 programs.



#### 2022 AIT Statistical Profile

- In 2022...
  - 15,600 new apprentice registrations (79% w/ Sponsor).
  - 6,000 Journeyperson or Qualification certifications issued.
  - 1,500 education credentials issued between STAEA's July launch and December.
  - Department staff visited over 9,500 employer sites or shops.



## RAP Apprentice New Registration by Year


Number of New Registrants in the Registered Apprenticeship Program (RAP) by Year<sup>1</sup>




## Top 15 Trades by Total Certifications
